## **Guidance notes**

### **Applications**

The fund is open to applications from community residents located within the Ardentinnny community council area.

The Application Deadline will be advertised to all members via email and community notices.

Applications should be submitted to the Secretary on the Application Form, who will acknowledge receipt. In some circumstances the Panel may ask for further information.

Applications can be for any amount. In general, it is preferable for applicants to source funds from more than one source, especially for larger projects.

### **Meeting Procedure and Frequency**

The Panel will meet up to four times per annum to consider applications. The Panel will normally meet in private but may occasionally request applicants to attend.

Awards may meet applications in full, in part, or not at all.

Awards will consider which applications have the greatest and widest benefit to the community of Ardentinnny and will do so with consideration both to the fund balance, the number of applicants, and to any previous awards.

There is no right of appeal but applicants can reapply even if they have been unsuccessful in the past.

The fund is expected to be topped up annually based on performance of the Hydro scheme. Should all the funds be distributed at the first meeting the second meeting will not occur.

In exceptional circumstances (e.g. disaster relief) the Panel may consider applications or make funding grants outside the normal meeting cycle.

### **Applicant Responsibilities**

Applications can supply back up information if they feel that is helpful; e.g. to substantiate major cost estimates.

Applicants are responsible for reporting on the use of funds and returning any funds unused within 6 months of the award. The Panel may ask for evidence of how funds were spent.

### **Panel Members**

The Funding Panel comprises seven representatives.

This Panel was nominated by the community at the AGM held on 22 May 2018 in the village hall  
Panel members will use their judgement to make awards in the best interests of Ardentinnny.
