A question had been raised in regard to the safety of the children in the village especially as there are will be more children with Actual Reality fully functioning. It was agreed that this will be put on the agenda for the next meeting. Aidan will be informed of this.

Councillor's Report.

Bruce reported that the spraying of Japanese Knotweed on the roadside along the shore has not yet been done. It was acknowledged that the sightlines are badly affected by this. Bruce will speak with roads department again. The training programme for dealing with JK is in the spring so there is time for a volunteer to be identified.

Bruce had been informed that the signs at the Larach have been done.

The 20% budget cuts have been postponed so the toilets will remain open at present at least to February when the budgets will be looked at again.

The closing date for nominations for community councillors is now past.

Val explained to Bruce that new information had been found out about the need for a Data Protection licence. The purchase of this will be put on hold until more details are investigated.

National Park Report

David McKenzie informed of the launch of Wildlife 2020. Further information can be gained from the website.

David gave an overview of the successful Open Day held in Kilmun.

Planning Day

David clarified the process of the NP Open Day. It was agreed that he would speak with Stuart Mearns to confirm a date. November 16th was a suggested day.

Community Grant funding is available to Community Councils and Community Trusts. One is for £750 for admin costs and another for £1500 for projects. It

was unclear which of these grants have been applied for by Community Trust. Val will contact Dennis to find out.

Project Funding

A request from Community Trust had been received for funding for paths. After discussion and vote it was unanimously agreed that this request would be turned down. Val will inform the Community Trust of this decision.

Village Pictorial Notice Board.

A suggestion had been made that the Community Council provide a pictorial notice board to be erected around the area of the car park. Some investigation has been done in regard to price, landowner etc. It was unanimously agreed to take this project forward. Agreement that an application would be made to National Park Community Grant funding for the notice board. Marian agreed to do this.

A planning application has been put in for 3 houses to be built in the land where the Anchorage is. Notices have been up on the board to inform residents. No objections have been received by CC.

A planning application for mobile mast in the Stronchullin area. This may benefit the reception received in the area. No objections received.
